INSURANCE, PERMITTING & TAXES: Required for all Retail Vendors

Each vendor must maintain Comprehensive General Liability Insurance of at least **one million dollars** (\$1,000,000). Please ask your Insurance Agent to provide a “Certificate of Liability Insurance” naming both Green Built Alliance, PO Box 17026, Asheville, NC 28816 AND City of Asheville, PO Box 7148, Asheville, NC 28802 as a **Certificate Holder AND as Additionally Insured**. The two certificates must be emailed to cari@greenbuilt.org by **Friday, Sept. 13, 2019** or you will not be able to be a vendor at the event. Exhibitors are responsible for complying with local and state tax regulations. Exhibitors are also responsible for North Carolina licenses and permits, as well as compliance with all food and alcohol regulations. **Each applicant selling items at this event** is responsible for obtaining and submitting to us a copy of your **Off-Premise Retail Permit & State Tax #**. If you are from **out-of-state**, you must provide a copy of your **NC permit** by **Friday, Sept. 13, 2019** or you won’t be able to be a vendor at the event.

Festival producers will make concerted efforts to mitigate the event’s environmental impact. A few rules apply: no styrofoam or single-use plastics, items must be recyclable or compostable, and all exhibitors participate in the waste diversion programs.

The vendor agrees to not hold liable any and all affiliates of Green Built Alliance and CiderFest NC for suits, claims, damages and loss or damage of property sustained while participating in CiderFest NC.
